

## RECYCFLUO – PRODUCTS LIST COVERED BY PHASE II – REPORTING STARTING OCTOBER 1<sup>ST</sup> 2013

The following table lists “recycling fee” rates for Phase II of the RecycFluo program. These fee rates will be applied on a per-unit basis to component mercury-containing lamps integrated into all types of lighting fixtures and automobiles, effective **October 1<sup>st</sup>, 2013**. Effected lighting fixtures are defined as electrical/electronic lighting products with a primary purpose to illuminate space that contain one or more replaceable mercury-containing lamps, including hardwired, free standing and portable products.

Effective October 1, 2013, members are required to report fees on the sale of each component mercury-containing lamp integrated into lighting fixtures and automobiles. For example, a member selling a street lighting fixture containing one HID lamp will be required to report and remit to the program one HID fee on the sale of that fixture. A member selling an automobile with two integrated HID headlamps would pay two HID fees on the sale of that automobile. The fee rates for component mercury-containing lamps (see table below) are the same as the fee rates applied to replaceable mercury-containing lamps sold individually. Component mercury-containing lamps integrated into lighting fixtures/automobiles and replaceable mercury-containing lamps sold individually are not required to be distinguished from each other on PCA’s online fee reporting system. As an example, if a member sold 300 HID lamps as replaceable/individual lamps in a reporting period and 100 fixtures with a single integrated HID lamp into each in that same reporting period, the member would report 400 HID lamps for that reporting period (Category 5).

### Phase II Fee Rates:

| Light Category   | Typical Size | Fee Per Unit |
|--|--------------|--------------|
| 1. Fluorescent/Induction/UV Tubes measuring ≤ 2 feet   | 2 feet       | \$0.30       |
| 2. Fluorescent/Induction/UV Tubes measuring > 2 feet and ≤ 4 feet  | 4 feet       | \$0.50       |
| 3. Fluorescent/Induction/UV Tubes measuring > 4 feet   | 8 feet       | \$1.00       |
| 4. Compact Fluorescent Lights (CFL) / Screw-In Induction Lamps   | n/a          | \$0.20       |
| 5. HID and Other: High Pressure Sodium, Mercury Vapour and Metal Halide, UV, Germicidal and UHP replacement lamps, xenon lamps | n/a          | \$1.10       |

The table listed below provides examples of lighting fixture types that can be sold with integrated mercury-containing lamps. Members that sell these types of lighting fixtures are encouraged to review their applicable SKUs to identify those that contain mercury-containing lamps for reporting purposes. It is expected that the majority of mercury-containing lamps sold integrated into lighting fixtures will be captured by these types of lighting fixtures. Regardless, it is each member’s responsibility to review their lighting fixture SKUs and report on the sale of integrated mercury-containing lamps in all fixture types, not just those listed below. Members are encouraged to contact the RecycFluo program if they identify an additional lighting fixture type sold with an integrated mercury-containing lamp so it can be added to the example product list.

## CFL AND OTHER MERCURY CONTAINING LAMPS INTEGRATED INTO FIXTURES

**Non-Linear Fixtures (Commercial and Industrial)** – Designed for use in commercial and industrial settings

**High / Low Bay Lighting**

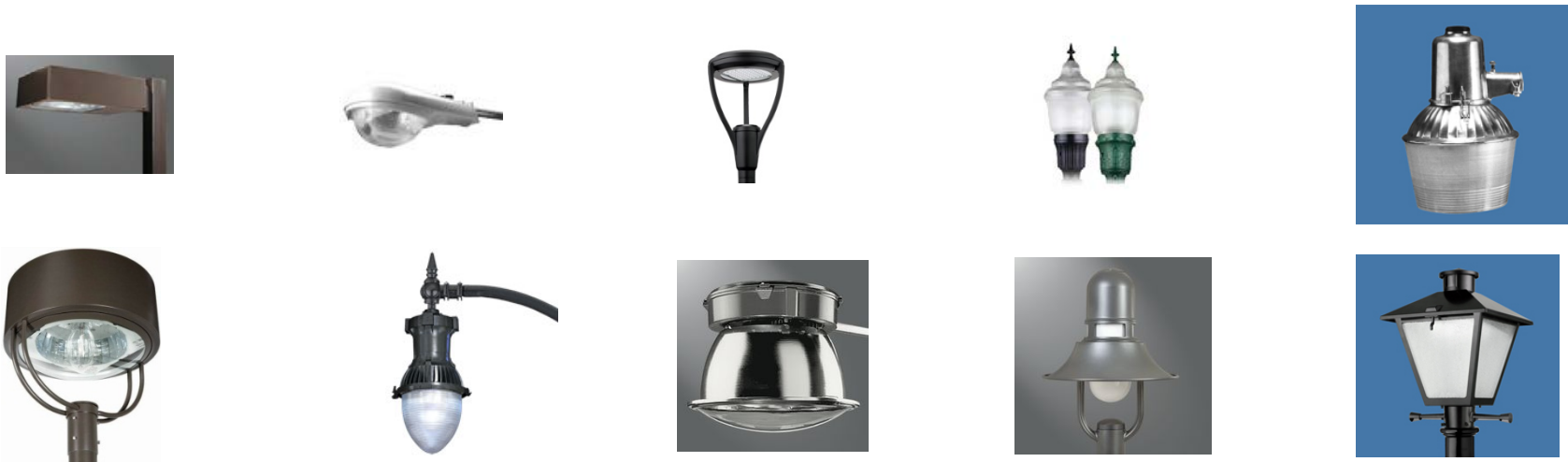


**Parking Garage Fixtures (Ceiling and Wall Mount)**



**Large Outdoor Fixtures** – *designed for use in institutional, commercial and industrial settings*

**Area, Highway, Street and Post Lighting** - Pole or arm mounted luminaries for sidewalk, street, highway, pathway or post-top lighting, including "shoeboxes" and "cobra heads." Non consumer applications only.



**Flood Lights and Sports Lights** – *designed for use in sports fields, stadiums, arenas, tracks, courts, industrial yards, parking lots, etc.*



**Other:** Closet fixtures with CFL; Ceiling fan with CFL; Xenon lamps; portable work lamp
